Here are my comments:

- Page 37 (Parks)- Could we please exclude Penrose Square as an example of a smaller park, since Penrose Square
 is an urban plaza (you could add Penrose Square as an example for plazas, and the fact that that place is being
 used for events, such as outdoor movies in summer.
- Page 37 (Plazas)- Welburn Square is spelled with one "I".
- Page 80 (Places to Start)- Long Branch is misspelled.
- Page 193- Please include the title of this section: Appendix B Synthetic Turf Fields (the same as it was before), leave word "placeholder" and remove all narrative. The idea is that we are leaving this entire appendix as a placeholder. We are not ready to share this information with the Committee yet, as more work is needed.
- Page 223- Same comment as above- please add Appendix G, Definitions, leave word "placeholder", and delete all of the narrative. We are not ready to share this with the Committee yet, as more work is needed.
- Page 209: LOS Maps- We were hoping to have LOS maps with focus areas circled, like we had before.
- Hold on to this one: Page 209: LOS Maps- Also, these maps still include permit-only fields, and we will have to revise them to show all of our rectangular fields, and most of our diamond permit only fields will become permit-takes priority, meaning they will have some community access (I will let you know after I speak with Erik, how do we want to address this; we will either exclude all of the field maps or have a note explaining that they will be revised).

Model Based On:

- Known participation in DPR and affiliate sports leagues
- Hours reserved for social leagues
- DPR prime time consideration on fields (e.g.; nights & weekends)
- Avg. spring & fall sunset
- All athletic fields excluding Abingdon & Claremont (unused) & community fields
- Maintenance hours goals by DPR
- Growth estimation based on population

Model Assumption:

- Number of players per team
- Avg. ideal hours needed per team per season
- Avg. amount of teams per field
- Ideal 13 week season for all leagues
- Community use is achieved by not including community fields in model (i.e.; ideally we aren't scheduling them anyway)

Does Not Consider:

- Participation numbers do not include APS, camps, community use, or other rentals
- Needs are not based on field quality (e.g.; we have many synthetic rectangles and most diamond fields are smaller, grass fields)
- Field demands exceed supply on all types of fields during the weekday evenings
- Field hours (per maintenance) needed for all other uses including APS, camps, and other rentals (hours are basically maxed out for leagues in 26 weeks)
- Available hours does not consider the limitations on APS & College fields (i.e.; often time during our prime time is used for games and makeups)
- Does not consider that we have multiple fields "out" in any given season
- Does not consider the higher rate of growth seen in youth sports (nearly 50%) nor the higher rate of growth seen in hours reserved on fields (29%) in past five years
- Does not consider the possibility of new sports leagues or other types of reservations
