**I-66 from Fairfax** – Exit at Spout Run Parkway to Lee Highway at bottom of ramp, turn right on Lee Highway, ½ mile turn right at light onto Veitch Street, right on Wilson Blvd., left on Adams Street, left on Clarendon Blvd., right into garage.

**From D.C.** – Via Key Bridge to Lee Highway (29-211), turn left on Veitch, right on Wilson Blvd., left on Adams Street, left on Clarendon Blvd., left into parking garage at 2100 Clarendon Blvd.

**From D.C.** - Via Theodore Roosevelt Bridge, take Route 50, right exit onto N. Courthouse Road, left at the 2<sup>nd</sup> light which is 14<sup>th</sup> Street, and right onto Veitch, directly into our garage.

**I-395 from Alexandria, Springfield and points south** – Exit at Washington Blvd/Columbia Pike exit. Take Washington Boulevard to Route 50 East to Washington; take the LEFT exit onto N. Courthouse Road, left at the 2<sup>nd</sup> light which is 14<sup>th</sup> Street, and right onto Veitch, directly into our garage.

**I-395 from D.C.** – Across 14th Street Bridge to exit for Washington Blvd/Columbia Pike/Ridge Road. Take Washington Blvd/Columbia Pike portion, take Washington Blvd. to Route 50 East towards Washington, take the LEFT exit onto N. Courthouse Road, left at the 2<sup>nd</sup> light which is 14th Street, and right onto Veitch directly into our garage.

**From Montgomery County** – Take I-270 S to I-495 S/Northern Virginia. Merge onto Capital Beltway/I-495 S. Take the VA-193 exit (number 43-44) toward GW Pkwy/Georgetown Pike. Merge onto GW Pkwy S via exit 43. Merge onto Arlington Blvd/US 50 W toward Rosslyn. Take the Court House Rd exit. Turn Slight Right onto N. Courthouse Rd. Take left at 2<sup>nd</sup> light, which is 14<sup>th</sup> Street, and right onto Veitch directly into our garage.

**METRORAIL** – This location is very easily accessible from the Orange line as the building sits on top of the Courthouse Plaza Metrorail Station. If you follow the regular Metro exit path, the building faces the AMC Theatre on the Plaza, but here is a shortcut note that will save you time. When you exit the train, take the escalator from the platform to the first level and exit the turn styles. If you look to your immediate right, you will see an elevator in a rather dark corner. Take the elevator to street level and enter the glass doors marked 2200. The secret is that 2100 and 2200 Clarendon Blvd are the same building. Go to the back of the lobby past the elevators and turn left into either of the dark wooden doors. You will arrive in the lobby of Arlington County Courthouse building. Turn to your left and take the elevators to the 5<sup>th</sup> floor.

\*\*\* Two & four hour metered parking is available at the east end of our building adjacent to N. Courthouse Road. There is also a parking garage directly under our building that provides both metered **and long-term parking at parking meter rates** (25 cents for 15 minutes). The garage is accessible from either Clarendon Blvd, or from the intersection of N. 14th and Veitch Streets. **The Kiosk to pay for parking is on level G1 in the 2100 Building.**
