Faisal – In preparation for our conversation tomorrow, I am sending you Arlington County's most recent (Fiscal Year 2018) data report on homelessness as well as the new Three Year Strategic Plan. As you will see from the data, our overall number of individuals who are homeless has decreased over the past 10 years. We just finalized the last year of our Ten Year Plan to End Homelessness. The annual Point-in-Time Survey shows a 56 percent reduction in the number of homeless persons in Arlington, from 527 in 2008 to 232 in January 2017. We have 5 shelters – 2 for families, 2 for singles, and one for victims of domestic violence. We also operate a hypothermia shelter during the winter months (November to March). Our numbers of street homeless have gone down due to a concerted effort in developing permanent supportive housing units – apartments with rental subsidies and supportive services for individuals who are permanently disabled – either physically or mentally. We strive to continue to provide safe and affordable places for vulnerable populations to live.

We look forward to discussing these issues with you further.
