As I mentioned to Holly, after review with our leadership earlier this week we have made a couple of minor edits to the performance agreement. They are:

- Section 9(o) – Confidentiality – clarified the language to show what we would release in the event of a FOIA request – essentially says the same thing just reworded
- Section 9(q) – Dispute Resolution – fixed a typo
- Section 9(v) – Limitations of Liability – added the County and IDA
