Hi Holly -

I would like to introduce you to Jill Hunger in AED – she works with our business community to help navigate the planning and development review processes, signage, and permitting issues. Jill did some preliminary research but probably needs to be connected to your staff person to get additional information in order to provide the correct guidance and make the right introductions.

A few questions include:

- particularly the location (central, yes, but on a street or private property?)
- the size of the vehicle (can our parking spaces accommodate it?)
- general time of day.

Jill's preliminary research suggests the Treasure Truck seems to look like a vending truck, therefore, it seems like obtaining a vending permit might be the appropriate path. Note that, if the truck fits within a legal parking space, it can "vend" for the lesser of two (2) hours or the lawful time limit prescribed for the respective parking meter zone. The Police Department oversees the permitting and licensing – though the Treasurer's Office & Office of the Commissioner of the Revenue are both involved too.
