Thanks again to all of you who were able to participate in our CCI Northern Virginia Node planning meeting and welcome to those of you who have expressed interest in being involved in the Node strategic planning effort. If you need background on the Commonwealth Cyber Initiative, please see the attached document entitled *CCI Blueprint final*.

We have received the Instructions for Application for Certification of the Regional Node (see attached *agenda-iten-4c-cci*). As we anticipated, a good deal of data will need to be assembled to meet the requirements for Certification.
